2024 Theme: "Voices of Democracy"

This year's theme recognizes that in democracies, the people rule. For nearly 250 years, Americans have expressed their political views and wishes by speaking up for fundamental rights, using the rule of law to enact positive societal changes, and voting in elections. However, individuals, nations, and democracies are never perfect. As you consider your entry in regard to this year's theme, answer ONE of the following questions:

- 1) In 2024, the United States will hold its 60th presidential election. The Electoral College is a critical part of the presidential election process. Make an argument for why the Electoral College does or does not represent the voice of the American people.
- 2) Which has been most influential voice in shaping democracy throughout history: social groups, institutions, or individual leaders? Make an argument for which you believe has had the biggest impact on expanding civic participation, incorporating diverse voices, and preserving democracy via individual or collective behaviors.
- 3) Our county's motto is "e pluribus unum" (out of many, one). Civic participation by citizens from diverse backgrounds who have a wide range of perspectives, beliefs and ideas is a necessary and desirable aspect of a democratic society. "Toxic polarization," however, is destructive and limits our ability to work together in a civil manner toward common ground. Suggest strategies to limit the impact of "toxic polarization" and to help people engage in productive civil discourse.

Entry must have been created without the use of any A.I. assistance and solely by entrant(s), who must own all rights to reproduce and/or publish entry in any medium without restriction. An entry cannot be submitted to more than one contest category. One entry per person per contest category.


Grades 6-12 Creative Arts Contest
